- H. Sounds emanating from the temporary use shall not adversely affect any surrounding property.
- I. TEMPORARY PROMOTIONAL BALLOONS are allowed for 15 days, three times per calendar year. A separate permit required can only be issued to a licensed contractor.
- J. TEMPORARY PROMOTIONAL SIGNS/BANNERS are allowed 15 days, three times per calendar year. A separate permit is required.
- K. TEMPORARY CONSUMPTION ON PREMISES: If a temporary alcoholic consumption will be offered, a temporary COP permit is required from Community Development. Visit the following page to download the application: http://cityofbonitaspringscd.org/special-events/

N. TEMPORARY HOUSING

- 1. A completed and notarized Temporary Use Housing Affidavit.
- 2. City fees for permit or inspection may be waived for a temporary housing unit associated with a natural disaster declaration.
- 3. For property located in a flood zone where the temporary housing unit is <u>not</u> highway ready (i.e. licensed, registered, and drivable), the maximum duration of the temporary mobile home, travel trailer, or park trailer is 180 days, with the ability to extend as appropriate.
- 4. For properties located outside of a flood hazard area, the maximum duration of the temporary mobile home, travel trailer, or park trailer is 18 months, or 540 days after the President of the United States issues a disaster declaration (the President issued a disaster declaration for Hurricane Ian on September 29, 2022).

5. CONDITIONS FOR USE

- a. Water and Sanitary Sewer must be provided
 - Connecting to water and/or sanitary sewer within BSU's service area must happen on the customer side beyond BSU's points of delivery (backflow preventer/cleanout). NO DIRECT CONNECTION TO

THE BSU CLEANOUT IS AUTHORIZED BY BSU OR THIS PERMIT. Sewer connections should be watertight.

- ii. A plumbing permit and inspection will be required to ensure that the connection to water and sewer is sufficient.
- iii. Notification to BSU will take place upon issuance of the permit.
- b. Connections to electricity utilities or any new power source will require an electric permit and inspection. The electric permit/trade permit can be added as a sub permit to the temporary housing permit.
- c. PLACEMENT: The temporary housing unit shall be located entirely on the property and shall not encroach into road rights-of-way, adjacent properties, or easements.
- d. The temporary housing unit must be removed from the property within ten (10) days after a certificate of occupancy has been issued for the new or rehabilitated residence, or upon expiration of the temporary use permit, whichever occurs first.
- e. The use of a mobile home, park trailer or other units that are not highway ready must comply with all floodplain management requirements of Chapter 24, Floodplain Management, of the City of Bonita Springs City Code.
- 6. ALL HIGHWAY READY UNITS (I.E. TRAVEL TRAILERS) SHALL BE REMOVED FROM THE PROPERTY DURING A POTENTIAL MAJOR STORM EVENT.
- 7. THE TEMPORARY HOUSING PERMIT MUST BE PLACED IN A WINDOW OF THE UNIT AND MUST REMAIN VISIBLE AT ALL TIMES

- 1. Tent(s) are less than 2,500 square feet and do not have sidewalls.
- 2. Tents will not be used for a placed of assembly (more than 50 people), kitchen or mess hall.
- 3. Tents will not block any driveway, fire hydrant or fire access to any building.
- 4. Tents will be at least twelve (12) feet from all property lines and have an unobstructed passageway or fire road not less than twelve (12) feet wide and free from guy ropes or other obstructions on all sides of tent.
- 5. One (1) classification type 2A fire extinguisher will be provided in every tent having a floor area of more than five hundred (500) square feet but less than one thousand (1000) square feet, and also one (1) in each auxiliary tent adjacent thereto. Two (2) classification type 2A fire extinguishers will be provided for each tent from 1000 to 25000 square feet.
- 6. "NO SMOKING" signs will be positioned approximately every twenty (20) feet around the perimeter if the tent.

 NOTE: At a minimum, all tents displaying or selling any sparklers shall have at least one (1) 10LB. 4A-60BC Fire extinguisher per NFPA-a Chapter-16.
- 7. Tents that will be occupied after sunset will have lights and emergency lighting.
- 8. Flame resistance certificates will be on the job site for inspection.
- 9. All other applicable requirements of N.F.P.A. 102 will be compiled with.
- 10. I understand that it is the responsibility of the permit holder to call the Inspections Office for inspection request and Bonita Springs Fire to receive final fire inspection prior to using the tent.

BUILDING AND FIRE MARSHALL CODES FOR TEMPORARY PERMIT

Permit Required

No person may erect, operate, or maintain a tent or air supported structure covering an area in excess of one hundred twenty (120) square feet without a permit. Tents used exclusively for camping are exempt from the above requirement.

Place of Assemblage

A place of assemblage includes any circus, carnival, tent show, theater, skating rink, dance hall or other place of assemblage in or under which persons may gather for any purpose.

Location of Tents and Air Supported Structures

- 1) A tent or air supported structure must be so located from any property line or permanent structure so as to be readily accessible by fire equipment.
- 2) Tents or air supported structures having an area of fifteen thousand (15,000) sq. ft. or more must be located not less than fifty (50) feet from any other tent or structure as measured from the side wall of the tent unless joined together by a corridor.
- 3) Tents and air supported structures may be joined together by means of corridors, but such corridors must be open to the sky. On each side of such corridor and approximately opposite each other, there must be provided openings not less than twelve (12) feet in width. These openings must be equipped with sliding curtains.
- 4) An unobstructed passageway or fire road not less than twelve (12) feet in width and free from guy ropes or other obstructions must be maintained on all sides of all tents or air supported structures unless otherwise approved by the fire authority having jurisdiction.

Structural Stability

Tents or air supported structures and their appurtenances must be adequately roped, braced, and anchored to withstand the elements of weather against collapsing.

Flame-Retardant Treatment

The side wall drops and top of all tents and air supported structures and all decorations must be of flame-retardant material or must be made fire retardant.

An affidavit or affirmation must be retained on the premises at which the tent or air supported structure is located, attesting to the following information relative to the flame retardant treatment of the fabrics:

- 1. Date fabric was last treated with flame-retardant solution.
- 2. Trade name or kind of chemical used in treatment.
- 3. The name or person or firm treating the material.
- 4. The name and address of the owners of the tent.

Fire-Safety Standards

- 1) Smoking must not be permitted in any tent or air supported structure. Approved "NO SMOKING" signs must be conspicuously posted.
- 2) No fireworks, open flame or other device emitting flame or fire may be used in or immediately adjacent to any tent or air supported structure while open to the public.

Fire Extinguishers and Other Fire-Protection Equipment

Fire extinguishers and other fire protection equipment must be provided in every tent or air supported structure as follows:

- 1. One 2-A type extinguisher must be provided in every tent or air supported structure having a floor area of more than five hundred (500) square feet but less than one thousand (1000) square feet and also one in each auxiliary tent or air supported structure adjacent thereto.
- 2. One additional 2-A type extinguisher must be provided for each additional two thousand (2000) square feet or fraction thereof.
